



GENERAL AGREEMENT FOR ACADEMIC COOPERATION

between

STEFAN CEL MARE UNIVERSITY OF SUCEAVA, Romania and

KAMIANETS-PODILSKYI IVAN OHIIENKO NATIONAL UNIVERSITY, Ukraine

Stefan cel Mare University of Suceava, 13, University Street, 720229, Suceava, Romania represented by Professor Valentin POPA, Ph.D., Rector and Kamianets-Podilskyi Ivan Ohiienko National University, 61, Ohiienko St., 32300, Kamianets Podilskiy, Ukraine represented by Professor Sergiy Kopylov, Doctor of Science, Rector

Hereinafter jointly referred to as Parties, and individually – Party, establish this General Agreement to foster international cooperation in education and common research fields.

- 1. Both parties agree to encourage the following activities, in particular, to promote international academic cooperation:
- 1.1. Exchanging students, scientists and academic staff within the frame of Erasmus+ or/and individual agreements;
- 1.2. Participation/organization of conferences and publication of scientific proceedings;
- 1.3. Reviewing scientific publication, thesis of dissertation, other research work;
- 1.4. Exchanging the information about seminars and scientific conferences organized by both parties;
- 1.5. Applying and participating in joint research projects;
- 1.6. Exchanging the information and documentation, including exchange of methodical recommendations, scientific publications and research results.
- 2. This General Agreement shall be applicable to educational and research organizations attached to each party.
- 3. This Agreement constitutes the entire agreement between the parties, and all prior discussions, agreements, and understandings, whether verbal or in writing, are merged in this agreement.
- 4. This Agreement is not considered a contract creating legal and financial relationships between the parties. Rather, it is designed to facilitate and develop a genuine and mutually beneficial exchange process/research relationship. To carry out concrete programs, the

parties will conclude other agreements as supplements to the present Agreement specifying financial and juridical responsibilities.

- 5. This General Agreement shall become effective as of the date of signatures of both parties. The Agreement may be amended by the written consent of the parties.
- 6. This agreement signed by the two Parties will remain valid for five (5) years. At the end of the five-year term, the agreement will be extended automatically for a further five (5) year period if no official request is otherwise taken into account.
- 7. This Agreement may be terminated by either party with a minimum of 120 days written notice. Activities in progress at the time of termination of this Agreement shall be permitted to develop and end as planned, unless otherwise agreed.
- 8. Each party shall designate a person or office to serve as liaison in order to implement this Agreement.
