

**Memorandum between KAMIANETS-PODILSKYI IVAN OHIIENKO
NATIONAL UNIVERSITY (UKRAINE) and AKAKI TSERETELI STATE
UNIVERSITY (GEORGIA)**

This agreement is made and entered by and between Kamianets-Podilskyi Ivan Ohiienko National University represented by the Rector Sergiy Kopylov and Akaki Tsereteli State University represented by the Rector George Gvartadze, referred to as the "Parties". The parties hereto agree as follows:

1. The Subject of the Agreement

The subject of this Agreement is:

- 1.1. Mutual scientific research, publishing, and educational activities, which will provide academic mobility;
- 1.2. Cultural cooperation;
- 1.3. The Agreement does not cover any financial obligations between the Parties.

2. Cooperation

- 2.1. Exchange scientific publication and other information
- 2.2. Mutual publishing activity (scientific journals, scientific articles, textbooks and etc.);
- 2.3. Exchange scientific and educational literature.

3. Forms of Cooperation

- 3.1. Students and academic staff participation in scientific conferences and seminars and publishing scientific papers and articles.
- 3.2. Mutual peer reviewing of scientific papers and dissertations, articles, reports and etc.;
- 3.3. Exchange in the field of tourism and cultural events.

4. Responsibilities

Each Party is obliged to:

- 4.1. Inform the other Party about scientific meetings, exhibitions, expositions and other activities; provide assistance in the participation.
- 4.2. Carry out the exchange of scientific information, offer know-how and share scientific experience on mutually beneficial terms.

5. Conditions

- 5.1. Cooperation Agreement shall take effect from the time of signature.
- 5.2. Either Party may terminate the Agreement if one of the Parties provided the other a written notice of termination no later than thirty days prior to the termination.
- 5.3. This Agreement may be amended at any time in writing by the Contract Amendment. The party wishing to amend this Memorandum of Understanding shall provide the other party written notice of the nature of the amendment.

6. The Terms of the Agreement

6.1. This agreement is valid for 5 years and it can be renewed for the additional 2-year period, unless one of the Parties provided the other a notice of termination.
